GA 100 : Muskoka Lakes Association

Muskoka Lakes Association fonds. - 1894-1994. - ca. 2 m of textual records and other material.

The Muskoka Lakes Association was organized in 1894 by a group of summer cottagers, and since then has worked on behalf of permanent or part-time residents of Lakes Muskoka, Rosseau and Joseph. "The Association was established to unite all those interested in the lakes and their vicinities in order to protect and promote the interests of property owners, cottagers and tourists, preserve the safe, healthful and sanitary condition and scenic beauty of the lakes; and to encourage skill and prudence in aquatic sports ... Association members were instrumental in forming the Muskoka Lakes Golf and Country Club, which is the scene of the annual regattas and other Association-sponsored activities. The Association has had a major influence on the history of the lakes since the beginning of the century."

Issues of interest to the Association since its beginnings have always included both political and environmental concerns: roads and other transportation facilities serving the area, sanitation standards, well-marked waters, fishing, fire and police services, taxation, water and air quality, acid rain, boating safety, and any other factors contributing to the health, security and pleasure of those living in and around the lakes.

Contents: fond consists of records documenting most aspects of the activities of the Muskoka Lakes Association from 1894 to the 1990s, with some gaps in coverage. Materials present include correspondence, committee minutes and annual reports, financial records, legal records, publications, ephemera, audiovisual material, and artifacts.

The fonds is arranged in 8 series:

1. Annual Meetings and Committee Minutes

2. Financial Records

3. Legal Documents

4. MLA Office Correspondence and Administration Files

5. Ephemera

6. Publications

7. Photographs and Audiovisual Materials

Series 1: Annual Meetings and Committee Minutes

Annual meetings and committee minutes. - 1894-1947, 1972-1986. - 42.5 cm of textual records.

Contents: series consists of records relating to the administration and activities of the Muskoka Lakes Association, and in particular the annual meetings, meetings of the executive committee, and meetings of association directors. The records demonstrate the concern for and activity surrounding the MLA's involvement in issues affecting the environment and the quality of life in the Muskokas and address such topics as water quality, acid rain, planning and land use, water levels, taxation, etc. Series includes minutes for the annual meetings of association directors (1980-1986), as well as attachments and supporting documents including agendas, financial statements, budgets, association newsletters, correspondence, lists of board members, reports, surveys and questionnaires, minutes of board sub-committees, ephemera, photocopied clippings, etc.

The minutes of the annual meetings, Executive Committee and other committees in the early years were found together by year and are filed together by year. Years for which no minutes exist in this collection have been assigned folder numbers so that should more minutes surface they can be filed in the appropriate place. In 1946, the Association began publishing the minutes of the Annual Meeting in its Yearbook.

Series 3 : Legal Documents

Legal documents. - 1980, 1983. - 0.5 cm of textual records.

Contents: series consists of documents of a legal and incorporative nature essential to the operation of the Muskoka Lakes Association as a legal entity. Includes the Association's constitution, letters patent, by-laws, and correspondence.

The Constitution was originally located after the last Executive meeting file. Copies of the letters patent and by-laws were originally located at the front of Minute Book #1, before the first meeting of directors. Photocopies now replace the originals in those files.
